

PRIVACY POLICY

Information notice pursuant to art. 13 of Regulation (EU) 2016/679 ("GDPR")

In compliance with the General Data Protection Regulation (EU) 2016/679 - "GDPR", and according to art. 13, we provide you with the necessary information regarding the processing of personal data provided.
